

THE TOWNSHIP AND COVID-19

The township has been following the guidelines issued by the State and Chester County Health Departments with respect to public gatherings and recreational activities.

Public meetings of the Board of Supervisors and Committees have been held by Zoom. Details for each meeting and how to access the meeting via Zoom are posted on the township website prior to the meeting.

The Board of Supervisors anticipates holding meetings via Zoom for the foreseeable future.

The township building will be open to the public Monday through Friday from 9:00 AM to 12:00 PM now until further notice. Please wear a mask when you come in.

The COVID-19 regulations affected the 2020 road program, forcing many projects until 2021. The Board of Supervisors did authorize the following roads to receive a tar and chip application this year.

- South Chester Springs Road
- Flint Road
- Horseshoe Trail
- St. Matthews Road and Red Bone Road

Miller Road

- (south of route 401)
- Fellowship Road
- Douglas Lane

The Board of Supervisors and the Public Works Department are working on a substantial road program for 2021.

The Board of Supervisors has taken a very strong proactive approach to understand how the pandemic is impacting the finances of the township. This is all as of mid-year.

- The most significant impact is the receipts from the Deed Transfer Tax, which were at a 22% of their budgeted amount with the slowdown in housing sales anticipated to continue through the end of the year. Receipts from this tax will not meet the budgeted amount.
- Receipts from the Real Estate Tax for 2020 are nearly identical to the receipts from last year.
- The revenue generated through the Earned Income Tax is surprisingly strong, at 52% of the budget. The Board of Supervisors anticipates that the budgeted amount for this tax will be realized.

The Board of Supervisors has identified more than \$300,000 in General Fund expenses that can be deferred, including finally funding the remaining segment of Fellowship Trail and purchasing a replacement vehicle for the Code Enforcement Office. The Board of Supervisors anticipates approving the design for the Fellowship Trail later this year after reaching an agreement to acquire the one (1) remaining easement.

On the whole, the Board of Supervisors are taking a very cautious and deliberate approach to manage the township's finances while meeting the demands of providing exceptional service to residents.

BRYN COED PARK DEMOLITION VVORK PROGRESSING

Despite a several week hiatus due to COVID-19 regulations, work on the demolition at the site continues. The project is estimated to be completed in mid-November. The township reopened the parking lot and marked a hiking trail through the park to support local access to the Natural Lands Preserve.

BRYN COED PARK TREE PLANTING

Seedling trees and shrubs, a

mix of native species including three (3) types of oak, red maple, walnut, flowering dogwood, spicebush, black willow, and red-twig dogwood, were provided by the **Chesapeake Bay Foundation** (CBF). Tree protection tubes were also provided by the CBF. In addition, a coir mat was installed to keep the growth down around the plant stem, making maintenance easier and allowing for establishment of the plants. Installation was done by Crow and Berry, a company specializing in riparian buffer installation; they have done work for Stroud Water Research Center, Lundale Farm, and Welkinwier, as well as for many farms and nonprofit organizations in the area. Plants are spaced to allow for mowing. Maintenance of the planting will be done by C&B along with volunteers for the first year. Green Valleys Watershed Association will provide an Operation &

Maintenance plan.

West Vincent Township is happy to welcome a new community organization to its list of civic activities!

On May 7, 2020, the Litter Lifters of West Vincent Township was officially recognized as a sub-committee of the Environmental Advisory Council. This grassroots group of volunteers organized in response to problem litter areas in our beautiful township. Spearheaded by WVT resident, Peter Reitmeyer, the group initially sought to organize a community clean up to commemorate the 50th Anniversary of Earth Day in April. The Covid-19 pandemic necessitated postponing this celebration. The group then evolved into a dedicated litter clean-up team fueled by the concern and commitment of multiple residents, most notably, Beth Intoccia. Litter clean-ups have already taken place along many local roads and streams, including but not limited to Horseshoe Trail, Hollow Road, Bartlett Lane, Birchrun Road, and Kimberton Road.

The Litter Lifters are eager to plan a larger community clean-up, targeting a two mile stretch of Route 401 near the township building, at a date to be determined in the Fall. This will be an on-going annual commitment as part of the PennDOT Adopt a Highway initiative.



READY FOR 100



The resolution was written by the WV Environmental Advisory Council (EAC) and endorsed by the WV Sustainability Committee. It sets the intention of the township to transition to 100% renewable electricity by 2035 and 100% renewable energy for heating and transportation by 2050. West Vincent committees and residents will be working together to meet this ambitious goal while respecting the needs and concerns of all who live and work in the township.

This clean energy resolution supports the township's existing Sustainability Plan that sets a goal to reduce the township-wide carbon dioxide emissions, and the Comprehensive Plan created by the Phoenixville Regional Planning Committee which has goals to lessen the impacts of carbon-induced climate change. West Vincent will be working with other Chester County communities on the first step of the transition – developing an energy transition plan. The plan will set goals, basic strategies, and initiatives to guide the township towards meeting the objectives of the program. The plan will also include emissions inventory of the township, programs to educate residents about clean energy options, and will maintain open avenues for the feedback and input from the community.

The initial West Vincent Clean Energy Transition Team (CETT) members are Ken Witek and Kathy McDevitt from the EAC and Kirk Reinbold and David Weber from the Sustainability Committee. The team has been busy here in West Vincent and is already working with other townships in the Phoenixville region and beyond.

The CETT will be forming plans with complete transparency and with input from residents and other stakeholders, taking the time to consider and address any concerns that arise.

A major focus of the effort will be on the sharing of information regarding renewable energy options so that residents and businesses can make their own energy decisions. By providing information, infrastructure improvements, and successful examples, and by collaborating with other communities and our township residents, the team hopes that all residents will choose to participate in reaching the goal of 100% renewable energy by 2050.

West Vincent has taken the first step on a long journey toward a cleaner, healthier future. The CETT will keep residents posted on the progress of the planning phase which is anticipated to occur through the end of 2021.

Program sponsored by the Sierra Club, which advocates for an affordable and equitable energy system across the United States powered by 100% clean, renewable energy such as wind and solar. West Vincent is the 161st community in the country, and eleventh (11) in Chester County to officially set community-wide energy transition goals. Neighboring communities that have also passed a resolution include the Townships of Uwchlan, East Pikeland, East Bradford, Kennett, Haverford, Radnor, Tredyffrin, Charlestown, and Whitemarsh, the Boroughs of Phoenixville, Downingtown, and West Chester and the cities of Philadelphia and Reading.

BUTTONWOOD LANE BRIDGE REPLACEMENT MOVING FORWARD



The Board of Supervisors recently awarded a contract to McMahon Associates, an engineering firm located in Exton, to propose a preliminary alternative design and layout for the bridge replacement.

The existing structures consist of concrete encased steel I beams which are in poor condition due to the age of the existing structure; the bridge needs to be replaced.

The alternative analysis will be based on the hydrologic and hydraulic analysis which will determine the preferred location and size of the new structure. It is anticipated that this task will be complete by the end of 2020.

The Board will select the best alternative and authorize continuation of this project. Due to the sensitive crossing of the Birch Run and the intersection with Hollow Road, the project will involve permitting and oversight from a number of outside agencies. The overall timeframe to completion is two-three years.
