Litter Lifters of West Vincent

2023 Year-end Report

The Litter Lifters of West Vincent Township submit this year-end report for 2023:

On June 19[,] 2023, the Board of Supervisors passed Resolution 14-2023 establishing the Litter Lifters of West Vincent (LLWV) as an Ad-hoc Committee of the Township.

The LLWV has been in existence since May of 2020.

Members of LLWV in 2023 included Beth Intoccia, Ann Dyer, Carys Egan, Dorothy Lynn, Ken Alan, Elisabeta Sheehan, Lia Provini, Gary Wescott, Traci Frederick, George Cooney, and Donna Delany.

Events:

In 2023, LLWV participated in 15 litter clean- up events, including 5 organized by LLWV within West Vincent Township. LLWV participates in PennDOT's Adopt-A-Highway program and has adopted Rt. 100 between Black Horse Road and Horseshoe Trail. One of the in-township events was fulfilling our PennDOT contract, which requires each group to do at least 2 clean ups in a calendar year.

In 2023, LLWV partnered with various groups throughout Chester County at different events. These partners include: PA State Senator Carolyn Comitta/Earth Day; Uwchlan Township EAC; West Pikeland Township; Green Valleys Watershed Association; E. Nantmeal Township; Young Ambassador with Keep Pennsylvania Beautiful; Kimberton Camphill Village; Owen J. Roberts High School clubs: Environmental, LEO, Equality Alliance, and Anchor clubs; Better Days Aheada nonprofit to help the homeless; Save the Schuylkill- a new non profit to protect the river; East Pikeland Township Open Space Committee; West Brandywine Police Department.

State Senator Katie Muth and her staff have participated in and promoted some of our events. PA State Senator Carolyn Comitta invited LLWVT to an Earth Day event at the Upper Main Line YMCA; Keep Chester County Beautiful, part of the Chester County Planning Commission, promotes our events.

LLWV utilizes the Clean Something for Nothing App to track all of our events. LLWV is the top user in the US for September 2023 - January 2024 with 85.8 liters of trash collected in that time period. (See screenshot below.)

Additionally, some members use the app to track individual clean ups that they do on their own. All clean-up events on state and local roads are tracked through the PennDOT portal and Keep Pennsylvania Beautiful.

PennDOT provides all of the trash bags, some safety vests and picks up the bags of litter and tires from state roads. A.J. Blosenski donated a large box of work gloves, safety vests and two roll-off dumpsters and hauled away the litter and 80 tires- project valued at \$4,000 for the Save the Schuylkill river clean up in August.

History:

When LLWV was formed in 2020, our primary focus was picking up litter in West Vincent Township. While LLWV has continued to improve our community, we have also helped other Townships and organizations with preparation for and participation in their events.

The progression of LLWV events, litter removed and value added is illustrated in the chart below.

The impact of our mission has grown due to the commitment of volunteers stepping up to help litter management in the Township. Through social media, word-of-mouth and promotion by the Township, the number of volunteers have increased significantly since our inception.

Outreach/Education:

In 2022, Beth was instrumental in bringing an affiliate of Keep Pennsylvania Beautiful to Chester County, as she saw the need to address the litter issue and support volunteers. As one of the wealthiest counties in PA, it was long overdue. The county commissioners added a new position of Sustainability Director in the Planning Commission to oversee environmental activities. This led to the creation of a Chester County web page entirely devoted to litter management.

As part of LLWV educational activities, Beth has created documents to help townships and groups outside of WVT to get started, and created display materials for libraries and schools: guide to plan safe, effective clean ups; steps to start a litter task force: guide to address safety, gather supplies needed for volunteer, share key contacts at PennDOT; connected with an artist who created a dog made entirely out of litter- created display boards for 2 libraries and West Vincent Elementary school. Beth did an educational presentation at the Longwood Rotary. Education about our county township and county litter issue is being addressed, and groups are being formed to clean up their own township roads.

Conferences/Workshops:

When LLWV was starting out, Beth Intoccia reached out to different organizations, such as PennDOT, Keep Pennsylvania Beautiful, CRC Watershed, Green Valleys Watershed, as well as individuals who had previously organized litter events in their communities. This allowed her to gather data and make many contacts within the environmental community.

As LLWV has evolved, Beth has continued to make contacts at different conferences and workshops.

In 2022, Beth attended the Litter Summit, and 2 day event in Lancaster held by Keep Pennsylvania Beautiful.
