 - 1. Meeting called to order at 7:06 p.m. by Chairman, Kirk Reinbold (Quorum present)
 - 2. Minutes from February 19 2022 meeting approved.
 - 3. Subcommittee Reports Energy (Kirk):
 - 3/16 consultant at township walked around building basement work shed, looking at hardware and equip for heating and cooling where thermostats are and LED lighting, data in addition to what they have to provide better audit on current standing
 - Identifying influencers and stakeholders (different) influencers are who they can – goal is to understand what communities attitude is on politics, etc
 - outreach specialist to help plan events (1-1 calls public meetings) –
 solar ordinance and building codes, add incentives to what we have –
 EX: don't have to pay for permit for solar site, private or public?
- 4. Trash and Recycling (John/Kirk):
 - John met with Sara Shick (Township Supervisor) and John Granger (Township Manager)
 - Goal: Census above 5k need to abide by PA Act 101
 - Develop trash and recycling education plan/outline
 - Learn more about haulers in WVT invite to Community Day?
 Resources available to incorporate in education plan and/or on website (Sustainability Plan also addresses trash and recycling education)
 - New ordinance not presented to Supervisors need ordinance from advisory committee (EAC, sustainability, planning committees)
- 5. Sustainability Plan (Kirk, Ken, and Tom):
 - 3 (three) meetings to date
 - Most recent plan: 61 (sixty-one) topics/initiatives some interrelated and will be divided out between committee members
 - From most recent plan: Number 1 initiative was most important at that time, but not aligned with Township's current priorities
 - Examples from last plan:
 - #11 priority require residents to pump septic systems every three years (in homeowners association – three-year rotation for service from one provider)
 - Does septic company collect data recommending three years but not requiring? Consideration: Pollution laws are so strict now
 - #12 priority Canadian Goose control on township land
 - Planted bushes to deter successful
