Ludwig's Corner Fire Company, Kimberton Fire Company and Ridge Fire Company shall utilize AVL (Automatic Vehicle Location) for mutual aid assistance.

**FURTHER, BE IT RESOLVED** the Uwchlan Ambulance and West End Fire Co. #3 EMS will provide Basic Life Support Services; and Ludwig's Corner Fire Company shall provide Quick Response Service to its designated territory; and,

**FURTHER, BE IT RESOLVED** the West Vincent Police Department will provide part-time police protection and the PA State Police providing part-time police protection; and,

**FURTHER, BE IT RESOLVED** the Ludwig's Corner Fire Company, Kimberton Fire Company and Ridge Fire Company will provide rescue service; and

**FURTHER, BE IT RESOLVED** Uwchlan Ambulance and West End Fire Co. #3 EMS will provide Advanced Life Support Services, and

FURTHER, BE IT RESOLVED Jim Gooding is designated as Emergency Management Coordinator; and

**FURTHER, BE IT RESOLVED** that the Board of Supervisors have reviewed and revised, if necessary, and adopted the West Vincent Township Emergency Operations Plan; and have reviewed and adopted the National Incident Management System as a common operating practice.

**AND FURTHER, BE IT RESOLVED,** the contact person(s) between said organizations and the Chester County Department of Emergency Services shall be John A. Granger, Township Manager.
