- Checks signed for 2 new Bird Town street signs!
- If we are not chosen by the Game Commission to receive a chimney swift tower for Opalanie Park, Kathy's husband will construct one, hopefully with the help of scouts.
- Donna will check with the Game Commission to see when they will decide if we will receive the purple martin condo for Evans Park and chimney swift tower for Opalanie.
- Discussion of possible future activities and events



- Live stake propagation in March we discussed that we can lead this spring workshop ourselves and not have to pay an outside teacher.
- Drew found out about a free tree giveaway. He will order 5 species of trees for us to give away to residents this fall.
- Dana told us the Dame Juliana League was going to plant 1500 trees in the riparian buffer at Wilson's Corner and Cooks Glen. Now, they do not have the manpower to do the planting, but they are offering us the trees.
  - Step 1 EAC members will go to these two spots and evaluate what help the riparian buffers need. Perhaps deer exclosures would work better than planting trees.

- Donna will check with Jim Wendelgass to see if he has new insights into pipeline relationships
- Dana said the township staff should be able to fill out the grant application, which is beyond the scope of the EAC members

### Botanical Sanctuary

- Charlene found an ideal spot in Opalanie Park, right next to the outdoor classroom. Hoping to get a fence and gate. Carys can help with a carved wooden sign for over the entrance.
- Charlene will coordinate with Ed Theurkauf.
- Motion Donna made a motion that the EAC spend up to \$300 from our budget if the Plant Savers grant does not cover the full cost of the plants. Barbara seconded, it passed unanimously.

  - Kathy will write a newsletter article about what the EAC is and what we do; Donna will back her up
  - Charlene will check out our webpage and see if they need updating. She will offer her latest article for posting on our page
  - We should let people know about how to deal with the recent spraying of our state roads with pesticide performed by PennDot. Bernie Couris is working with PennDot to minimize future damage. We could let people know they can sign up for the USDA chemical sensitivity list and that they can put up No Spray Signs.
