Township Park Rules & Regulations

Park users must abide by all signs
Park hours are from dawn to dusk
No littering or dumping

Pets must be leashed at all times. Animal waste must be removed by the owner.

No fires or camping

No commercial activity or soliciting

Motor vehicles are permitted in the driveways and park lot areas only

No alcohol or illegal substances allowed in the park at any time

No illegal discharging of firearms, no fireworks, rockets, explosives or weapons

No excessive noise or indecent language

No hunting or shooting

No demonstrations without specific permission from the Township Manager

No glass containers

No skateboarding or roller skating/blading

Balloon Bounce structures/devices are not permitted

Staking canopies or tents to the ground requires Township Manager approval

No defacing or damaging property

No wading, swimming or ice skating in the pond

No camping, archery, golfing or horseback riding

No disturbing wildlife or vegetation

All reservation requests for park, gazebo and/or field requests must be made by completing the Park/Gazebo Rental Form or Field Use Reservation Form with payment of associated fees.

As contained on the rental and reservation forms, all park visitors and users must agree to indemnify, defend and hold harmless West Vincent Township, its agents, employees, servants, successors and assigns from any and all claims and losses in connection with the usage of the park and its facilities

Township Manager approval is required for: pavilion reservation, league use of sports fields, parades, ceremonies, musical events, theatrical or other entertainment and public meetings or gatherings.
