New Business

- HOA Connections we will continue to make our list, with possible help from the county.
- Nature Tenders
 - We completed and filed our application for the Chester County Lawn to Meadow Conversion Program, with help from new township manager, Tommy!
 - Nature Tenders event on April 5 will focus on fixing and replacing tree tubes and removing invasives from the tree tube area.
 - Opalanie Mowing Schedule we discussed again the best management practice to mow the meadow areas of the park to discourage invasive plants while also providing winter cover and protecting ground-nesting birds, pollinators, native plants, and Monarch butterflies. We agreed that the ideal would be to mow half of the fileds in November, then the other half that had not been mown yet the next November. We discussed fox hunting in the park, and agreed it should not be permitted when the ground nesting birds have started building their nests. Rachel will check on the timing.
 - Kathy will look into reusable name tags that we could wear for events so that people could identify us
 - The live stake planting area around the pond was not staked off, and it needs to be. Donna will check on it.
 - Elementary School Earth Day Celebration no one is available except Donna, so we will skip it this year.

Healthy Yard

- Donna made a motion that the First Annual Healthy Yard Garden Tour would be held on July 19 from 9-noon with a raindate of July 20. Kathy seconded. The motion passed unanimously. The first step would be contacting our healthy yard recipients to see if they would be interested in participating.
- We will ask Rachel Griffith at the upcoming NCC-EAC meeting if any township has created an ordinance that prevents herbicide applications by outside agencies such as Peco and Penn Dot or at least requires notification of the township manager and residents with chemical sensitivities. Donna has asked Bird Town and is waiting to hear back.

 - The Garden Talk and Seed Giveaway scheduled on March 11, 2025 was cancelled due to the speaker's family emergency.
